98.5 WOMG "JOHN MELLENCAMP" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WOMG ("Station"), 1301 Gervais St., Suite 1950, Columbia, SC, 29201, during available business hours Monday through Friday, on the Station website www.womg.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **98.5 WOMG "JOHN MELLENCAMP"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 6:00 ET on Friday, November 3, 2023, to be eligible for a chance to win a prize. Message and data rates may apply. The station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.
- 4. **Winner Selection**. On or about 12:00 PM on Monday, November 6,2023, Station will select [10] potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. [winners will be selected by who submitted the correct keyword given out by Chris Logan. Monday through Friday from 3pm-6pm on Tuesday, October 31 until Friday, November 3. Once received tickets will be sent to winner's emails unless told otherwise.] Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3)

days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

- 5. Verification of Potential Winner.
